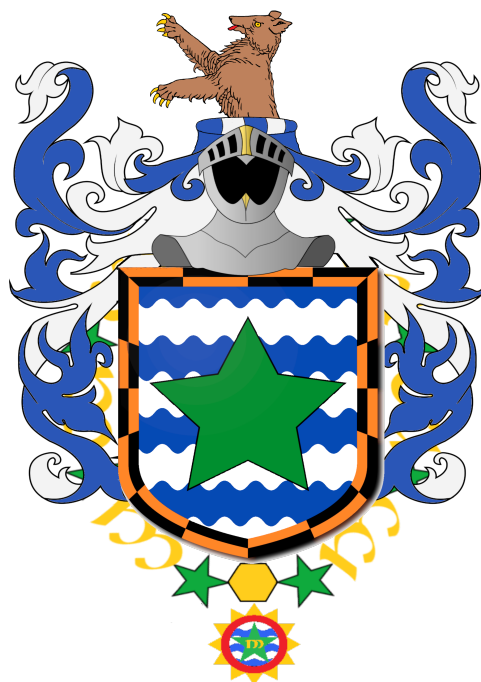




JOHN Duke of Númenor, Marquess of Meneltarma, Earl of Amon Sûl, Viscount Mitheithel, Baron Fornost, Protector of Imladris, Knight Grand Cross of the Most Noble Order of the Flame of Anor, Knight Grand Commander of the Most Illustrious Order of Beren and Luthien, Knight of the Order of the Evenstar, Bearer of the Queen's Own Congratulatory Ribbon, Freeman of the Shire, Grand Master of the Númenórean Order of Merit, Fellow of the Galadhrim, Prince of Gondor, Prince of Arnor, Prince of Laurelindórenan, Until the King Return, Regent and Guardian of the Crown of Gondor and Arnor, To all unto whom these presents may come, **GREETINGS** and the King's Peace!

WHEREAS His August Majestie's right trusty and well-beloved Counsellor my good brother Sir Danny O Snow, Knight of the Most Excellent Order of Elbereth, Bearer of the Númenórean Order of Merit, Freeman of the Shire, Lord Keeper of the Privy Seal, Representative of my Palatine Duchy of Númenor in the King's Council-General, Poet Laureate of my Duchy of Númenor and sometime Lord President of the King's Councils, has long served informally as heir to my Dukedom Marquessate Earldom Viscounty Barony and Protectorate being styled in that capacity Marquess of Meneltarma and **WHEREAS** our nearness of age suggests the wisdom of formally designating an heir and successor younger than either of us while reserving to my said brother his style and precedence as Marquess of Meneltarma for the term of his natural life, **NOW THEREFORE KNOW** that I of my own free will and volition having in mind the preservation of the King's peace within these realms and my own household and for the furtherance of the good governance of the said Kingdoms as well as of the fame and honour of the Dukedom of Númenor, Marquessate of Meneltarma, Earldom of Amon Sûl, Viscounty of Mitheithel, Barony of Fornost, and Protectorate of Imladris, and reposing full faith and confidence in the loyalty judgement and circumspection of His August Majestie's good servant

and in his ability to take part in the deliberations of His August Majestie's councils and in pursuance of the Peerage Continuity and Officers' Incapacity Act of 7533 have named the said **JESSE** to be my lawful heir and successor in my said Dukedom Marquessate Earldom Viscounty Barony and Protectorate willing that he should succeed to the said peerages and enjoy the style title estate dignity name honour and preeminence of Duke of Númenor, Marquess of Meneltarma, Earl of Amon Sûl, Viscount Mitheithel, Baron Fornost, and Protector of Imladris and enjoy and exercise all of the rights and privileges to all or any of these peerages ministries or offices appertaining. And in respect of this designation I assign and grant unto the said **JESSE** the use of the arms of the said Dukedom duly differenced, viz., **Barry wavy Azure and Argent, a mullet Vert, a bordure counter-compony Tenné and Sable, and for a crest upon a wreath of the liveries a demi-bear rampant proper armed Or and langued Gules**, as is more clearly depicted in the margin hereof, and appoint him a Knight Bachelor of these Kingdoms and Grand Bailiff of my said Númenórean Order of Merit, with all the privileges and duties thereof. In witness whereof I have revoked and do hereby revoke annul cancel and hold for naught any and all previous nominations and designations and have hereunto set my hand and signet, and have caused a copy hereof to be deposited in the archives of the Lords Great Steward. Given at my City and Fortress of Osnúmenor this sixteenth day of Girithron in the Seven Thousand Five Hundred and Seventy-fourth year of the Fourth Age, being being the forty-eighth of my Regency and the fiftieth of my Dukedom.
