

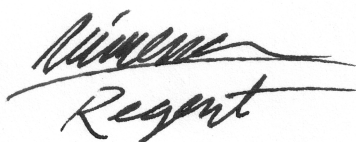
JOHN Duke of Númenor, Marquess of Meneltarma, Earl of Amon Sûl, Viscount Mitheithel, Baron Fornost, Protector of Imladris, Knight Grand Cross of the Most Noble Order of the Flame of Anor, Knight Grand Commander of the Most Illustrious Order of Beren and Luthien, Knight of the Order of the Evenstar, Bearer of the Queen's Own Congratulatory Ribbon, Freeman of the Shire, Grand Master of the Númenorean Order of Merit, Fellow of the Galadhrim, Prince of Gondor, Prince of Arnor, Prince of Laurelindórenan, Until the King Return, Regent and Guardian of the Crown of Gondor and Arnor, to **EUGENE** Duke of Minhiriath, Marquess of Mirkwood, Earl of Enedwaith, Viscount Calenhad, Baron Calenhad, Baronet, Knight Grand Cross of the Most Noble Order of the Flame of Anor, Knight Commander of the Most Excellent Order of Elbereth, Knight of the Most Illustrious Order of Beren and Luthien, Freeman of the Shire, Fellow of the Galadhrim, Prince of Gondor, Prince of Arnor, Prince of Laurelindórenan, Lord Great Steward of Gondor and Arnor and Bearer of the White Rod of the King's Faith, Lord Great Chamberlain of Gondor and Arnor, and Shirrif of the Shire, GREETING and the King's Peace!

An it please Your Grace, WHEREAS, having been appointed a Duke having Palatine Authority under the New Administrative Areas Act, I am authorized and empowered thereby to create peers and peeresses of the ranks of Baron or Baroness and Baronets and WHEREAS I have in the past exercised the authority aforesaid and WHEREAS **Sir Sumner Tristan Hunnewell**, Knight of the Most Noble Order of the Flame of Anor, has been present in support of his Right Honourable father, the Viscount Tookland, His August Majestie's Secretary of State, and his Right Honourable and Worshippfull mother, the Viscountess Tookland, Mayor and Representative of the City of Caras Anduinad, at past Councils-General of these Realms and WHEREAS I have determined it to be needfull and necessary to the maintenance of Justice and Mercy and Truth and Virtue and Peace and the King's Majestie that I exercise the aforesaid authority, NOW THEREFORE I **JOHN** DUKE OF NÚMENOR AND REGENT OF GONDOR AND ARNOR by and through the exertion of my Palatine Authority aforesaid and of my own certain knowledge special grace and mere motion, revoking my warrant of the twenty-ninth day of Norui in the Seven Thousand Five Hundred and Fifty-Eighth year of the Fourth Age, and having in high regard the noble lineage and gentle family from which he is sprung and being assured of his courage and perspicacity and confident of his loyalty and virtue and being now mindful of the support and aid and succour and assistance which he has always and diligently rendered unto the Most Dread Sovereign our King and being eager and desirous to reward him for his many services do and do now by these presents request and require Your Grace to issue a Writ of Summons in Acceleration to His August Majestie's Council-General to His August Majestie's good true and trusty servant the aforesaid **SIR SUMNER TRISTAN HUNNEWELL** in his father's **BARONY OF HUNNEWELL-OF-TUCKBOROUGH** desiring that he shall have and enjoy Until the KING Return all the rights precedence privileges prerogatives and duties appertaining to the rank or station of a Baron in these Realms, intending particularly that he hold the said rank or station as fully as if he had inherited the same and not in contravention of the provisions with regard to courtesy titles of Section Five, Article Three, of the Peerage Continuity and Officers' Incapacity Act of 7533. And for so doing, these presents, or a facsimile hereof, shall be Your Grace's warrant: and herein fail not, at your peril.

In witness whereof I have hereunto set my Hand. Given at my City and Fortress of Osnúmenor this Sixth day of Lothron, in the Seven Thousand Five Hundred and Seventy-fourth year of the Fourth Age, being the forty-eighth of my Regency and the fiftieth of my Dukedom.
