* The Compact with the Forodrim of 7545 provides that: “All Peers, Nobles, High Ministers, Great Officers of State, members of Orders of Chivalry, Kings of Arms, Herald, Pursuivants, Governors-General, Lieutenant Governors, Mayors, Judges, Masters of Lore, persons holding land or office of His August Majestie, Esquires, Ladies and Gentlemen and all other persons entitled to some form of rank or precedence under the ordinary

jurisdiction of one of the High Contracting Parties shall, when travelling or resident within the other's jurisdiction, be accorded rank and precedence with but after persons holding the nearest equivalent title, office, honor or dignity under that other's jurisdiction; and the Marshals, Heralds or other designated agents of each of the High Contracting Parties shall from time to time jointly advise the persons having responsibility for precedence under the jurisdiction of each of the High Contracting Parties as to what the several equivalencies may be."
